Nevada Corporation Registration Package

Unless otherwise mentioned, the quotation of U.S. Corporation specifically refers to a company limited by shares registered in Nevada, USA, in accordance with the Nevada General Corporation Law.

Introduction

The basic package fee to register a Corporation in Nevada is USD 2,200. This package fee includes Kaizen registration service fee, registered address in Nevada and registered agent fee (for one year), a set of standard bylaws, and the registration fee collected by Nevada Secretary of State.

To register a Corporation in Nevada, the documents provided by you include the business name that plan to use, the maximum number of shares authorized by its board of directors and par value of the shares, identification (e.g. passport) and residence address proof (e.g. utility bill, bank statement, etc.) for each shareholder, director, and manager (and secretary, if requested) of the Corporation.

If neither the business name contains any restricted words, nor there is any special license requirement for certain business operation, the Corporation registration schedule is about 5 business days. You can also request expedited service. In this scenario, the most expedited service is to accomplish the registration within 24 hours of filing the order to government. (Extra service fee needed).

1. Corporation Registration Services and Fees

Our fees for handling the registration of a Corporation in Nevada is USD 2,200, including the following services:

- (1) Checklist for the registration and archives
 - (a) Kaizen professional registration service fee;
 - (b) Check name availability for the Corporation;
 - (c) Pay registration filing fee to Nevada Secretary of State;
 - (d) File the Initial List of officers, directors, registered agent, apply Nevada State Business License, and pay the registration fee;
 - (e) Standard Bylaws in Nevada;
 - (f) Minutes of first meeting of board of directors;
 - (g) Compile Board Resolution for opening a business bank account, if requested;
 - (h) Customize a corporate kit, including metal corporate seal, stock certificate, shareholder list, register of director, and stock transfer ledger etc.
- (2) Registered Address and Registered Agent for the first year

Kaizen will offer a registered address in Nevada and arrange a registered agent service for the first year in compliance with the requirement of Nevada Secretary of State.

Notes:

- (1) Kaizen fees quoted above do not include any document delivery fee during the business registration process, if any.
- (2) Kaizen fees quoted above exclude the taxes. If you request tax invoice, value-added tax at the prevailing rate may be charged and collected.

2. Other Relevant Services

(1) EIN application

To identify and levy taxes on the corporations, the Internal Revenue Service requires each entity to obtain an Employer Identification Number (EIN). EIN is applied from Internal Revenue Service (IRS), and takes around 3 weeks to process. Expedited service is not available. Kaizen service fee for EIN application is USD 300. Kaizen will notify you through Email once received the EIN from the tax authority.

(2) ITIN application

If the Corporation is required to apply the Sales/Use permit, or plan to open a business bank account in U.S., or the responsible person of the Corporation is required to file individual tax return, then the responsible person must apply Individual Taxpayer Identification Number (ITIN) from Internal Revenue Service (IRS). The processing time is about 6 to 8 weeks, and it may take up to 11 weeks during tax season (Jan - April). Expedited service is not available. Kaizen service fee for ITIN application is USD 1,000. Kaizen will notify you through Email once received the ITIN from the tax authority.

(3) Sales/use tax permit application

If the Corporation intends to sell or lease tangible personal property at retail or offer certain taxable service in Nevada, the Corporation is required to obtain a sales/use tax permit from Nevada Department of Taxation. The processing time is about 3 to 6 weeks. Expedited service is not available. Kaizen service fee for seller's permit application is USD 450. Kaizen will notify you through Email once received the sales/use tax permit from the tax authority.

Note: The Corporation must make a security deposit to the Nevada Department of Taxation if the monthly sales tax liability is over USD 1,000. The amount of security deposit is three times of the estimated tax due if file sales/use tax monthly, or twice of the estimated tax due if file quarterly.

(4) State and local business license application

Generally, the Corporation will obtain the Nevada state business license at the same time the Corporation complete the registration with Nevada Secretary of State.

If the Corporation registered at Nevada with registered address provided by Kaizen, there is no need to obtain state/local business license when the Corporation's business doesn't involve any marijuana related business and the Corporation will not hire employees or set up business office/warehouse at Nevada.

If the Corporation engages business in Nevada and has employees or office/warehouse at Nevada, please consult with Kaizen consultants whether local city/county business license is required and the application process.

(5) Federal business license application

The Corporation is not required to apply Federal Business License, unless the business activities are regulated by the federal authority. The regulated business activities include agriculture, alcoholic beverages, aviation, firearms, ammunition and explosives, fish and wildlife, commercial fisheries, maritime transportation, mining and drilling, nuclear energy, radio and television broadcasting, transportation and logistics. If needed, please consult with Kaizen consultants for details on the application process and fees as these depend on the business activity and the federal agency issuing the license.

(6) Open a business bank account in U.S.

The Corporation will meet the requirements to open a business bank account in U.S. after obtaining the EIN and ITIN. Kaizen consultants provide onsite assistance for the responsible person to open the business bank account. The service fee is USD 500. Please notice that the responsible person of the Corporation is required to be interviewed and sign related documents onsite under the witness of the banker. Kaizen only provide the onsite assistance for the responsible person in New York.

(7) Provide mailing address

Kaizen offers a New York address as your business mailing address. The mailing address can be used to receive letters from bank, government, and other related business letters for the Corporation, then Kaizen will forward these letters to you through email (by default) or mail (if necessary). The service fee is USD 500 per year, not includes delivery fees if you prefer receive documents by mail.

(8) Authentication

Kaizen provides the notary service for the formation documents, including authentication in Nevada Secretary of State and Chinese Consulate General and Certificate of Incumbency. If needed, please consult with Kaizen consultants for more details on the process and fees.

3. Payment Time and Method

Kaizen requires to collect the full-service fee before starting the registration process. Kaizen accepts cash, bank transfer and wire transfer, check, and PayPal. You are responsible for the service fee, if any. For example, Kaizen will charge an extra 5% for the transaction fee when PayPal method applied.

4. Fundamental Structure of a Corporation in Nevada

Minimum requirements for a Corporation registration in Nevada:

- (1) At least one incorporator, can be a shareholder or officer;
- (2) At least one shareholder. The shareholder can be a legal entity or natural person, without nationality limitation;
- (3) At least one director. The director can be shareholder, officer (and secretary, if requested), but must be a natural person;
- (4) At least one officer, who must be a natural person;
- (5) The director or officer can sign legal documents on behalf of the corporation and record minutes of meetings;
- (6) The number of shares authorized to issue by board of directors and the par value;
- (7) The business address should be in Nevada.

5. Registration Procedures of a Corporation in Nevada

The registration procedures for a Corporation in Nevada are listed as follows:

| 9 | Kaizen will undertake the Certificate of Incumbency or certified copy of registration document, if being engaged to do so; | TBD |
| 10 | After the above procedures are completed, Kaizen will deliver all the documents to you at the address designated. | 1 |

Note:

- (1) The number of days stated above are estimations and for reference only. In addition, they are estimated based on the assumption that no application for license or permit is required.
- (2) For No.5, if expedited service is requested, the registration will be processed within 24 hours with extra expedited service fees USD 350.

6. Documents Required to Register a Corporation in Nevada

You should offer the following documents to Kaizen:

- (1) Names of the proposed company. Please provide 2 to 3 preferred names in priority order;
- (2) Passport copy and residential address proof (utility bill, phone bill, or bank statement, etc for the most recent 3 months) in respect of each shareholder, director, officer (and Secretary, if requested) of the Corporation. If the shareholder is a legal entity, please provide the entity's registration document and registered address;
- (3) The maximum number of shares authorized by its board of directors and the par value;
- (4) The detailed description of the Corporation's main business activities, such as the services intend to offer or products intend to sell, and location of potential customers/suppliers;
- (5) Date of commencement of business;
- (6) Number of Employees, if any;
- (7) Duly completed "due diligence questionnaire" provided by Kaizen.

The identification and address proof, mentioned in (2), should be certified or notarized by Kaizen, local notary at the place of the shareholder and manager, lawyer, CPA, or bank manager.

7. Documents for You After the Registration

After all the registration procedures, the following files will be mailed to you for their archives:

- (1) Articles of Incorporation sealed by Nevada Secretary of State;
- (2) Standard Bylaws in Nevada;
- (3) Initial list of officers and directors, and Nevada State Business License;
- (4) Corporate seal customized with the Corporation's name;
- (5) The minutes book, which used to record shareholder list, register of directors, and stock transfer ledger, etc.;
- (6) Minutes of first meeting of Board of Directors;
- (7) 10 pieces of blank Stock Certificates;
- (8) EIN letter, if any;
- (9) Certificate of Incumbency and certified copy of registration document, if any.

The above documents are also available for pick up in any Kaizen offices.

8. Annual Renewal

A Corporations in Nevada should file an annual report each year. Kaizen service fee for the annual renewal is USD 1400, including provision of registered office, registered agent, filing of Annual List of officers/directors, and renewal of Nevada State Business License. Please note that this service fee does not include accounting and income tax filing. We will send a renewal notice to you 2 months before the due date.

9. Other Compliance Services

A Corporation is also required to operate in compliance with the Nevada General Corporation Law. For example, keeping all the vouchers and receipts, filing income tax return, and file annual report, etc. Kaizen U.S. office is a professional CPA firm, offers complete compliance services and business support, such as bookkeeping, financial statement audit, filing tax return, making payroll, etc. Please consult with Kaizen consultants for more details.
